Chairman's Foreword



Looking back, this has been a very interesting year for the Chamber. Key milestones have included the addition to the Board of Richard Swart and Peter Maila, the formation of the Executive Committee, the creation and work of the Awards Committee, which has been responsible for making tonight's event happen, and the formation of a number of other Committees whose work is just beginning.

The membership has grown by 25% in the past year and registered users have gone up 20% (larger base). This increased engagement has supported re-energised Chamber events and the development of the Business Hub. The Business Hub will service three key markets – British companies wanting to invest in South Africa, South African companies wanting to be involved in offshore markets and UK based South African linked businesses and members generating business from a UK base.

Our Trade focused business – Transact SA is working on its first trade missions to SA and from SA, focusing on agriculture and agritech. Our Business Hub is addressing large businesses' interests in SA, creating "solutions" services for smaller businesses, introducing members to members and enabling other contacts to foster members' successes. The Chamber is working on a project to "invest" in SA university business graduates learning to run successful farms.

Following a year of consolidation and restructuring, the Chamber is focused on future sustainable growth. To achieve this, the Chamber will evolve from only pro bono volunteers to employing a few dedicated staff; a major milestone for the Chamber.

GDPR is a current focus and we encourage opt-in responses to mailings going out over the next couple of weeks.

Over the next few months The Chamber will be holding many interesting events including Summer Drinks on 6th July at the residence of the High Commissioner in Kensington, a cocktail evening with the SA Rugby Sevens, breakfast with Nelson Mandela's prison warden, dinner with Mike Proctor and a property investment panel discussion.

I wish all members, prospective members and friends a great year.


